In consideration of the services provided by SKILLZ Ball Academy, their agents, officers, participants, consultants, employees, and all persons or entities acting in any capacity on their behalf (hereinafter referred to as SKILLZ Ball Academy). I now agree as follows:

I acknowledge and fully understand that I, _____, the participant (if participants is 18 years of age or older) or parent/legal guardian of the above listed minor participant, will be engaging in activities that may involve risk of serious injury which might result not only from my own actions, inactions, or negligence, but from the actions, inactions, or negligence of others or the conditions of the premises or of any equipment used. Further, that there may be other risks not known or not reasonably foreseeable at this time. The risks may include, but are not limited to: nature of the activity, latent or apparent defects of conditions in equipment or property supplied by SKILLZ Ball Academy or other entity; acts of other participants in this activity, employees or agents of SKILLZ Ball Academy, my own physical condition, acts of omissions; conditions of SKILLZ Ball Academy, facility and surrounding grounds or terrain and accidents connect with their use; first aid emergency treatment or other services.

I expressly agree and promise to accept and assume all the risks existing in this activity. My participating in this activity is purely voluntary and I elect, in spite of the risks, to participate. I assume all the foregoing risks and accept personal responsibility for the damages following such injury.

On behalf of myself, my children, my parents, my heirs, assigns, personal representative I hereby voluntarily release, waive, forever discharge, and agree to indemnify and hold harmless SKILLZ Ball Academy and of their respective commissioner, directors, agents, and other employees, its parent, subsidiaries, affiliate, employees, distributors and agents, other batting cage participants, and if applicable, operator or lessors of premises used to conduct the event/activity, from any and all liability for any and all claims, demands of causes of action which are in any way connected with my participation in this activity or my use of SKILLZ Ball Academy equipment or facilities.

I hereby certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating in these activities or alternatively I agree to bear the cost of such injury or damage myself. I further certify that I have no medical or physical conditions, which could interfere with my safety in this activity, or else I am willing to assume and bear the costs of all risk that may be created, directly or indirectly, by any such condition.

I hereby certify that I am at least 18 years old, or the part or legal guardian of the participant under 18, and I agree I will wear a batting helmet at all times while in the batting cages. I hereby provide SKILLZ Ball Academy permission to administer basic first aid and I authorize SKILLZ Ball Academy or its agents or employees to contact 911 or other emergency personnel as needed.

I hereby certify that I have been given the Rules & Regulations for batting cage use and will adhere to them.

I do hereby give SKILLZ Ball Academy its assigns, licensees, and legal representatives the irrevocable right to use photographs or video in all forms and media and in all manners, including composite, for advertising or marketing for publications or any

Indoor Facility and Batting Cage Code of Conduct

1. Batters **MUST** wear helmets inside cages at all times.
2. Only the staff of SKILLZ Ball Academy are permitted to adjust pitching machines. If the SKILLZ Ball Academy staff is away then Adults attending the session should responsibly and without breakages should adjust.
3. A waiver must be signed before use of any of the equipment by any user who is 18 years of age or older (Parent/guardian must sign for any minors).
4. Adults are responsible for the actions of the youth in the training area.
5. Misconduct will result in immediate termination of privileges. Horseplay/fooling /Vandalism will not be tolerated.
6. No food or drinks allowed in the training areas.
7. All balls must be picked up and returned to their proper place after use. Equipment is any has breakdown, shall be reported to the owners of SKILLZ Ball Academy.
8. Batters must wear appropriate shoes. Turf shoes allowed, **NO CLEATS, NO SPIKES** or any other shoes or equipment that will damage the carpet.
9. No person under the influence of Drugs or Alcohol is permitted to use batting cages.
10. Alert the attendant immediately if balls are throwing out of strike zone.
11. Balls may be pitched at any time. **BE ALERT** at all times.
12. No one under the age of 6 years old is permitted to use the pitching machines.
13. Anyone under the age of 16 must have adult supervision on site.
14. Helmets and bats must be provided by the user.
15. The only people swinging a bat are those inside the individual tunnels.
16. Do not throw balls back at pitching machines. Do not interrupt or scare players in the cages.
17. This is a family atmosphere; no profanity or vulgar language/gestures will be permitted.
18. Booking cage(s) on behalf of a group – person booking shall be responsible for following rules and regulation of the group booking.
19. In case of disputes, decision by owners of the SKILLZ Ball Academy shall be final and cannot be challenged.

CAUTION! Injuries could result from the use of these devices. Users should assume the inherent risks of batting, Cricket balls, Base balls and Soft balls. If users have any questions about the use of these devices or the inherent risks associated with the use of these devices, ask the attendant before using the batting cages
